A JOINT ACTION RESOLUTION OF THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE
CROW TRIBAL GOVERNMENT

A JOINT ACTION RESOLUTION REQUESTING THE CROW TRIBAL ATTORNEYS TO ASSESS THE
CROW TRIBE'S LEGAL RIGHTS TO REVENUES AND/OR SERVICE FROM THE ELECTRICAL
POWER GENERATION AT YELLOWTAIL DAM..

WHEREAS, the Crow Tribe sold land to the U.S. Bureau of Reclamation in 1958 for the construction
site of Yellowtail Dam in he southern portion of the Reservation; and

WHEREAS, no revenue was ever negotiated or received by the Crow Tribe from the electrical
generation produced by Yellowtail Dam; and

WHEREAS, the electrical generation at Yellowtail Dam is a valuable resource that was not included in
the sale of the Dam area nor in the subsequent law suit which provided additional revenues to the Crow Tribe;

THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE
CROW TRIBE:

New Section. Section 1. To request the Crow Tribal Attorneys to assess the Crow Tribe's legal rights to
revenues and/or service from the electrical power generation at Yellowtail Dam.

New Section. Section 2. Codification instructions.



