**JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATURE AND THE
CROW TRIBAL EXECUTIVE BRANCH ENTITLED:**

**“SUPPORT AND AUTHORIZATION FOR THE CROW TRIBAL CHAIRMAN TO
PURSUE EXPANDED GAMING OPPORTUNITIES FOR THE CROW TRIBE.”**

WHEREAS, the Crow Tribal Legislature is authorized by Article V, Sections 2 and 3 of the Crow Tribal Constitution and Bylaws, to promulgate and adopt laws, resolutions, ordinances, codes, regulations and guidelines for the governance of the Crow Tribe of Indians; and

WHEREAS, the Executive Branch is authorized by Article IV, Section 3 of the Constitution to represent the Tribe in negotiations with other governments and entities in matters of welfare, social services and economic development affecting the Tribe, and to engage in business that will further the economic well-being of Tribal members and undertake economic development activity;

WHEREAS, the Crow Tribe's current gaming activities at Little Big Horn Casino are relatively limited; and

WHEREAS, expanded Tribal gaming activities will provide further opportunities to support economic development and employment for the Tribe and Tribal members, as well as providing additional revenues for the Tribe;


NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE:

“That the Crow Tribal Legislature acting jointly with the Crow Tribal Executive Branch hereby authorizes the Chairman of the Executive Branch and his designees to investigate and pursue additional gaming opportunities for the Crow Tribe, and to negotiate agreements to provide for expanded Tribal gaming activities, with such agreements to be presented to the Legislature for final approval as required by the Crow Tribal Constitution.”




CERTIFICATION
