JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATURE AND THE  
CROW TRIBAL EXECUTIVE BRANCH ENTITLED:

**“REGARDING CROW TRIBAL MEMBERS ATTENDANCE  
AT OFF-RESERVATION BOARDING SCHOOL”**

**WHEREAS**, THE CROW TRIBE is a federally recognized Indian Tribe with all rights and power which acts through its governing body with authority to protect the welfare and promote the well-being of its citizens pursuant to the 2001 Constitution of the Crow Tribe of Indians; and

**WHEREAS**, the education of Crow Tribal members is an important step to increasing the welfare of all citizens of the Crow Tribe and the Crow Indian Reservation; and

**WHEREAS**, the elected officials of the Crow Tribe, as well as Crow Tribal Education Department staff have been asked by tribal members to intercede on their behalf to arrange for attendance at an off-reservation Boarding School; and

**WHEREAS**, these school-aged children would benefit by having the opportunity to attend educational facilities funded by the Bureau of Indian Education outside of reservation boundaries; and

**WHEREAS**, the BIA/BIE may pay traveling costs of these children to attend those educational facilities, provided the tribe adopts a resolution waiver allowing the children to travel to those facilities; and

**NOW THEREFORE BE IT RESOLVED**, that the Crow Tribe through this Joint Action Resolution states that the Crow Tribe will allow its school-aged children to attend those off-reservation educational facilities and have the BIA/BIE pay for those costs; and

**BE IT FURTHER RESOLVED**, that the Executive and Legislative Branches of the Crow Tribe Executive Branch hereby request on behalf of the Crow Tribe that the Bureau of Indian Affairs/Bureau of Indian Education accept this Joint Action Resolution providing for Crow school aged children to attend educational facilities outside the boundaries of the Crow Indian Reservation.




**EXECUTIVE ACTION**




