**LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE
ENTITLED: "RE-ORGANIZATION OF SUB-COMMITTEES"**

WHEREAS, the Crow Tribal Legislature is authorized to adopt resolutions, regulations, ordinances, codes and guidelines for the governance of the Crow Tribe of Indians, pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians approved by the Secretary of the Interior on July 14, 2001; and

WHEREAS, in reference to an amendment to LR 02-17 passed Thursday January 12th 2006 which establishes 2 year term limits to the sub-committees of the Legislative Branch,

WHEREAS, there are currently nine (9) existing subcommittees, Health & Human Services, Economic Development, Revenue, Ethics, Education, Natural Resources, Judicial, Infrastructure Development, and Personnel subcommittees.

WHEREAS, the Crow Tribal Legislature amends establishing two (2) year term limits to one (1) year term limits.

WHEREAS, The Crow Tribal Legislature finds that this distinct branch of government will re-organize all nine (9) existing subcommittees at the beginning of each New Year instead of at the first official meeting.

WHEREAS, the current nine (9) sub-committees consist of a Chairman and Secretary.

WHEREAS, the Crow Tribal Legislature sub-committees will have elections at the same time as the elections for Speaker and Secretary of the House at the beginning of each New Year.



BE IT ENACTED BY THE LEGISLATURE OF THE CROW TRIBAL GOVERNMENT:


THAT, there will be an election for chairman and secretary of the subcommittees every January, Hereafter;

Further, the Crow Tribal Legislature will re-organize all sub-committees at the beginning of each January Session.

FINALLY, the current nine (9) existing subcommittees will have elections at the same time as the elections for Speaker and Secretary of the House at the beginning of each New Year.


CERTIFICATION
