LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE APPROVING, ADOPTING AND DIRECTING TO HIRE AND EMPLOY LESLIE PLAINFEATHER AS A LEGAL ASSISTANT FOR THE LEGISLATIVE BRANCH

WHEREAS, the Crow Tribal Legislature is a separate and distinct branch of government under the 2001 Constitution of the Crow Tribe; and

WHEREAS, the Crow Tribal Legislature is authorized to adopt resolutions, regulations and guidelines for the governance of the Crow Tribe of Indians, pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians, approved by the Secretary of the Interior on July 14, 2001; and

WHEREAS, the Crow Tribal Legislature requires technical and professional support in the exercise of its constitutional authorities, including legal research and preparation of legal documents; and

WHEREAS, the Crow Tribal Legislature has established the position of legal assistant to provide support to the Legislative Branch legal office; and

WHEREAS, the position of legal assistant is currently vacant; and

WHEREAS, the Personnel Committee has recommended the Crow Tribal Legislature hire and employ Leslie Plainfeather as the legal assistant; and

WHEREAS, the Crow Tribal Legislature has determined that it is necessary and proper to hire and employ a legal assistant as soon as possible.

NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE:

THAT, upon approval by majority vote the Crow Tribal Legislature shall hire and employ Leslie Plainfeather as the legal assistant.

FINALLY, the action directed herein shall take effect immediately upon approval by majority vote the Crow Tribal Legislature and the Legislature directs that the Legislative Branch Speaker and staff take all necessary actions to act as herein directed.




