

## **July 2010 Regular Session of the Crow Tribal Legislature**

Legislative Resolution No. LR10-17

Introduced by Senator C.J. Stewart, Black Lodge District

A Legislative Resolution Titled:

### **A Resolution of the Crow Tribal Legislature to Add “Parks and Recreation” to the Legislative Fish and Wildlife Committee Title and Purpose**

**WHEREAS**, the Crow Tribal Legislature (“Legislature”) is authorized to adopt resolutions for the governance of the Crow Tribe of Indians pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians;

**WHEREAS**, the Legislature passed a Resolution in the April 2010 Session establishing the Fish and Wildlife Committee in order to review tribal policies related to proposed laws, regulations, and intergovernmental agreements pertaining to the management of fish and wildlife;

**WHEREAS**, many tribal members and non-tribal members recreate on the Reservation by hunting, fishing, camping, hiking, boating, and other activities;

**WHEREAS**, there is a need for legislative committee review of outdoor recreation activities subject to tribal regulation and the establishment of tribally-managed recreation areas.

### **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL LEGISLATURE IN REGULAR SESSION:**

That the Committee on Fish and Wildlife Management shall be known henceforth as the “Committee on Fish, Wildlife, Parks, and Recreation”;

#### **Be it further resolved:**


That the Committee on Fish and Wildlife Management, Parks, and Recreation shall draft and review proposed tribal legislation associated with the purpose of this Resolution and shall conduct a continuous review of the current management activities of Crow tribal government relating to outdoor recreation, including but not limited to hunting, fishing, camping, hiking, horseback riding, off-road vehicle use, boating, biking, and snowmobiling;

#### **And be it finally resolved:**

That this Resolution shall take effect immediately upon passage by the Crow Tribal Legislature.




